

#### **Annual Review 2014 – 2015**

### HC DrugFree Presented 21 Educational Programs in Fiscal Year 2014 -2015

More than 3,400 people attended HC DrugFree's programs in 2014-2015. During the October program at Howard High School, students and staff learned about opiate abuse and the dangers of these drugs. At the November **Parent2Parent** program at Wilde Lake Interfaith Center, parents shared their stories of family members' struggles with addiction. HC DrugFree partnered with Centennial High School's PTSA in January to present **Who are Molly and Her Friends?**, a program for parents to learn about current drugs available in Howard County, including concert drugs such as Molly. At a **Teen2Teen** program at Atholton High School, teens and parents heard young people tell their stories of addiction and recovery.



More than 350 parents and teens attended the two annual **Senior Week: Staying Safe in Ocean City** programs in the spring at River Hill and Mt. Hebron High Schools in partnership with their PTSAs. In the April **Pre-Prom Assembly**, juniors and seniors at River Hill learned about the dangers of drinking and driving, and in May, Atholton's Pre-Prom Assembly featured a parent who lost her son to a drunk driver.

HC DrugFree supported all 12 Howard County Public School PTSAsponsored **After Proms** by donating \$25 gift cards to each. 104 parents

entered HC DrugFree's annual drawing to win a \$100 gift card to support parents who chose to send their child to After Prom instead of private parties where alcohol and other drugs may have been present. The 2015 winner was Amy Schroeder whose son attended the Howard High School After Prom.

### **Advocated for Our Youth**








#### **Teen Advisory Council**

# **HC DrugFree's New Initiative**

As part of this initiative, HC DrugFree released 6 videos and associated talking points for parents to use as discussion starters with their teens and other parents.

#### **Drug Take Back Day**

The Howard County Police and HC DrugFree partnered to promote Drug Take Back Days during which a total of 1,659 pounds of medications were collected in the Fall of 2014 and the Spring of 2015 for proper disposal. Prescription drugs are now the number one drug abused by 12 to 13 year olds. The number of teens reporting to have misused or abused a prescription drug at least one has risen by 33% in a five year period and now represents twice the population of Chicago. Safely storing or properly removing medications from homes is a simple but important step in ending prescription and over-the-counter drug abuse by youth.

# **NIDA Drug Facts Chat Day**

HC DrugFree partnered with the National Institute on Drug Abuse (NIDA) for the annual Drug Facts Chat Day, where NIDA provided an online access code for Howard County teens to communicate with NIDA experts about drugs and drug abuse, how to help friends or family who are abusing drugs, and what causes addiction, and NIDA experts gave them the facts. More than 8,000 questions were submitted to NIDA, 869 of which were from Howard County teens.

### Overdose Response Training
