The Howard County Police and HC DrugFree partnered to promote Drug Take Back Days in the Fall of 2016 and the Spring of 2017 for proper disposal. Removing medications from homes is a simple but important step in ending prescription and over-the-counter drug abuse by youth. # Needles/Syringes/EpiPens Collected for Disposal

Thanks to the partnership with the Howard County General Hospital (HCGH) and the support of Dr. Andrew Angelino, HCGC's Director of Psychiatry, HC DrugFree's office served as a drop-off site for the collection of needles, syringes and EpiPens during our fall and spring medication collections.

#### **NIDA Drugs & Alcohol Chat Day**

HC DrugFree partnered with the National Institute on Drug Abuse (NIDA) on their annual Drug & Alcohol Chat Day, where NIDA provided an online access code for Howard County teens to communicate with NIDA experts about drugs including alcohol and drug abuse, how to help friends or family who are abusing drugs, and what causes addiction, and NIDA experts gave them the facts.

In August 2016, Executive Director Joan Webb Scornaienchi received the Leadership in Youth Engagement Award from 7th, 8th and 9th grade girls from across Howard County who participated in the Women's Giving Circle's annual summer leadership camp. The event was held at Howard Community College.

In October 2016, Joan received the Innovator of the Year Award for her commitment to opioid misuse prevention and education. The event was held at the American Visionary Art Museum in Baltimore.
