<u>Successfully Collected More Than 2,000 Pounds of Medication and Sharps at</u> Convenient Drive-Thru Collection

On April 28, 2018, HC DrugFree's team of volunteers were busy from 10 a.m. until 2 p.m. in the Wilde Lake Village Center parking lot collecting 952.5 lbs of unwanted and expired prescription and over-the-counter medication as well as 18 bins of sharps (needles, syringes, and EpiPens). Maryland's Lt. Governor Boyd Rutherford presented HC DrugFree with a Governor's Citation. Dr. Calvin Ball presented HC DrugFree's Executive Director with a County Council Resolution. At the October 2017 collection, HC DrugFree's team collected 1,212 lbs of medication and 17 large bins of sharps.





Howard County Teens Kick Butts

Members of HC DrugFree's Teen Advisory Council (TAC) remind the community about national Kick Butts Day, a national day of activism that empowers youth to stand out, speak up and seize control against Big Tobacco. Great strides have been made in the fight against tobacco, but daily, more than 3,000 youth under 18 try smoking for the first time and 700 youth become new daily smokers. Tobacco use remains the leading cause of preventable death in the U.S., killing more than 480,000 people each year.

Substance Use and Its Impact on Academic Achievement and Mental Health

HC DrugFree, Howard High School PTSA, and Bonnie Branch Middle School PTA partnered to present: Substance Use and Its Impact on Academic Achievement and Mental with expert speaker Dr. Amelia Arria.

Dr. Arria's research has focused on the risk and resiliency factors that contribute to mental health and substance use problems among adolescents and young adults. Her most recent work has clarified the impact of substance use, particularly excessive drinking and marijuana use, on academic achievement. She is the Principal Investigator of the NIH-funded prospective College Life Study, which annually assessed the behavioral health of 1,253 college students through their young adult years. Much of her work has direct relevance to parents, communities, educational professionals and policy makers.
