HC DrugFree is keeping Howard County *In the KNOW!!!*

Before The Clock Strikes Midnight This New Year's Eve

Last December, with only a few days remaining in the 2017 calendar year, HC DrugFree told you that Howard County was reporting 56 fatal overdoses and 169 non-fatal overdoses. This year, we're heading into the final 2018 calendar days at less than 50 fatal overdoses, but with more than 180 non-fatal overdoses.

As we wait for the clock to strike midnight this New Year's Eve, and we wait for the final 2018 overdose reports to be made public, we at HC DrugFree aren't celebrating. Instead, we are reflecting upon the pain overdoses are causing Howard County families as well as families across this State and country.

More than 50 deaths and the increasing non-fatal overdoses remain unacceptable to us and to many of you. These are sons, daughters, husbands, wives, and friends. Families and the community experience the painful ripple effects of these overdoses - fatal or not.

We'd like to use this opportunity to thank Howard County's first responders for the challenging jobs they perform throughout the year and the many ways they go above and beyond to try to keep us all safe.

Register For FREE Parenting Classes

Howard County parents/guardians of 9 to 14 year olds are invited to join HC DrugFree and the Howard County State's Attorney's Office for our next *Guiding Good Choices* 4-week parenting program.

Feedback from the fall 2018 sessions was amazing, so hurry to register!

Adult participants will learn the skills to reduced the risk that their children will use drugs. After completing the program, families will be able to: **Influence** their children to help prevent drug use and other risky behaviors; **Develop** clear family guidelines and expectations about drug use; and **Teach** children how to stay out of trouble, keep their friends and still have a good time.

Classes will be held on Tuesdays, **March 5, 12, 19 and 26**. Adults are expected to

attend all 4 sessions. Unless otherwise notified, all meetings will be held at the Elkridge Branch of the Howard County Library from 5:30 p.m. to 8:00 p.m.
