Learning Life Skills in Middle School

HC DrugFree is proud to partner with Dunloggin Middle School to provide a highly interactive and skills-based program designed to promote positive health and personal development for youth in grades 6-8. The integrated approach helps to develop personal, interpersonal, and drug resistance skills.

This middle school program uses developmentally appropriate, collaborative learning strategies to help students achieve competency in the skills that have been shown to help students resist substance use (tobacco, alcohol and other drugs), violence, and other high-risk behaviors.

Nearly Half a Million Americans Died from Drug Overdoses this Decade

There have been 467,000 drug overdose deaths in America so far this decade, which has triggered a public health emergency. Opioids were the leading cause of these deaths, but in recent years, deaths from overdosing on strong synthetic drugs have increased. <u>Click here</u> to read about this decade's drug epidemic and

Drug Company Distortion of Medical Evidence

When drug companies fund medical studies, the results usually overplay their benefits and downplay their harms, and when doctors accept marketing from these companies, they are more likely to prescribe unnecessary medication to their patients. Safe Talk Training

Safe TALK is a 3-hour training that helps participants recognize and respond to a person with thoughts of suicide. The participants will become suicide alert helpers and learn how to connect the person with thoughts of suicide with resources to help them choose to live. CEUs are available.
