## YES, Our Howard County Teens Are Still Vaping!


...so be sure you attend HC DrugFree's next parent program, *Not My Child: Vaping and More*, being held this Wednesday, January 29 at 7:00 p.m.

HC DrugFree and the Marriotts Ridge High School PTSA invite all <u>adults</u> to learn more about vaping and other drug use in Howard County. At this program, the Howard County Police will be sharing their data with the community.

Also presenting and available to answer your questions will be Mark Donovan, Clinical Supervisor at both Congruent Counseling Services and Integrative Counseling in Columbia, and HC DrugFree's Executive Director, Joan Webb Scornaienchi.

Mr. Donovan will be sharing a recently released longitudinal study that demonstrates how damage caused by vaping is similar to that of smoking cigarettes. Pictured: Ms. Scornaienchi and Mr. Donovan.

## Registration Now Open! Free Parenting Classes

HC DrugFree and the State's Attorney's Office are offering another series of parenting classes. Guiding Good Choices is an evidence-based, interactive prevention program that provides the families of children age 9-14 with the skills and knowledge to reduce the risk that their children will use drugs.

The program is for parents. Children age 9-14 are invited to attend the third session with their parents.

After completing the program, families will be able to:

- Influence their children to help prevent drug use and other risky behaviors,
- Develop clear family guidelines and expectations about drug use, and
- Teach children how to stay out of trouble, keep their friends and still have a good time.



## Middle School Life Skills Update

At HC DrugFree's 5th Life Skills class held at Dunloggin Middle School, students learned about alcohol to counter common myths and misconceptions. They attempted to walk in a straight line while wearing goggles that simulated the feeling of being under the influence of alcohol. They discussed why some teens stay sober and why others decide to drink, as well as how people become problem drinkers.

## Save the Date: Medication and Sharps Collection, Saturday, April 25

HC DrugFree's next convenient drive-thru medication and sharps collection will be held on Saturday, April 25 between 10 a.m. and 2 p.m. in the Wilde Lake Village Center parking lot. Free. No need to get out of your vehicle. We accept all unwanted or expired over-the-counter and prescription medication as well as needles, syringes and EpiPens. Start collecting. Howard County Police and the Drug Enforcement Administration will guard and transport the collected medication.

# Do You KNOW What Teens are Using?

- One in four 12th graders say they vaped nicotine in the past month, along with one in five 10th graders, and nearly one in ten 8th graders.
- One in five 12th graders reported that they vaped marijuana sometime in the past year, nearly double the year before.
- When asked why they vape, many teens said they like the flavor, to

- experiment, for social reasons, or to feel good. Notably, the number of high school seniors who say they vaped because they are "hooked" more than doubled in the last year.
- Teens' use of many drugs continues to decline, including misuse of prescription opioids, cigarette smoking, and alcohol use.
