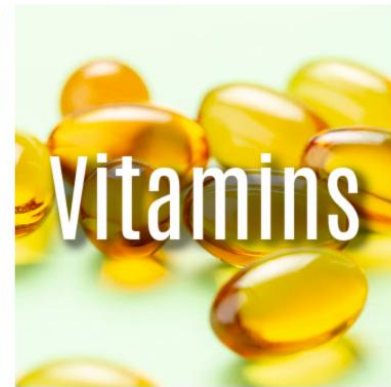

We are accepting:

- Prescription Medication
- Over-the-Counter Medication
- Vitamins
- Pet/Veterinary Medication
- Sharps (Needles, Syringes, Epi-Pens, etc.)
- Vape Devices (with batteries removed)
- Inhalers

No need to remove medication or labels from the bottles. If dropping off sharps AND medications, please make sure sharps are not mixed in with your meds. Sharps must be in designated sharps containers or secured in a way that our team can't get pricked.

**REMINDER: Due to health restrictions we cannot return your bags, boxes, or bins as we may have in the past. Please plan accordingly.**

Medications are guarded and transported by the Howard County Police Department and the Drug Enforcement Administration (DEA).

Due to Covid-19 we are requesting that participants wear masks, including those staying inside vehicles. We thank you in advance for taking this precaution to protect our volunteers and community.
